The Local Emergency Planning Committee (LEPC) is supported by the City of Corpus Christi. Nueces County and the Port of Corpus Christi Authority through a five (5) year Interlocal Agreement, which will be in effect through 2024.







The year 2020 proved to be an extremely challenging one, with the arrival of COVID-19 and the ensuing global pandemic. The normal operations of the LEPC were paused in March, but its goal remained the same: educating the residents of Corpus Christi and Nueces County about potentially hazardous chemicals in the community, teaching citizens what actions to take during a chemical emergency, how to shelter-in-place and/or evacuate and where to find information during a chemical emergency.

Prior to COVID-19 gathering restrictions, the LEPC was able to present information and provide materials to several organizations including 125 people at the Education Service Center Region 2, the annual Xeriscape Symposium and the TCEQ Regional Water Resiliency Workshop. The LEPC attended two in-person meetings of the Coastal Plains LEPC, and a meeting of the Damage Prevention Council in Alice in January. Once COVID-19 gathering restrictions were in place, public service announcements on television and radio, a new wrap on the LEPC van, a more active Facebook page, a redesigned website and numerous online meetings allowed the LEPC to safely and remotely distribute information.

A secondary goal emerged for LEPC: providing materials and information to various groups operating in the time of COVID-19. The LEPC assisted in coordinating with Port of Corpus Christi Authority the distribution of hand sanitizer to Meals on Wheels volunteers and recipients, coordinating a donation of personal protective equipment from Valero for local fire departments and recording an audio presentation for the Corpus Christi Community Advisory Council's driveby meetings.

#### **OVERVIEW**

In addition to public education, the LEPC continues to fulfill its statutory duty as set forth in the Emergency Planning and Community Right to Know Act (EPCRA) to collect and maintain annual Tier II chemical inventory information from facilities in Corpus Christi and Nueces County that use, store and/or produce hazardous chemicals. The LEPC responds to public requests, as well as first responders, by providing Tier II information when appropriate.

The LEPC's scheduled meetings were limited in 2020 due to COVID-19 restrictions. Meetings that did occur either in person or online included: Executive Subcommittee meetings in January and October, Risk Awareness Subcommittee meetings in February and October, Emergency Response and Communications Subcommittee meetings in January and October, Pipeline Subcommittee and General Meetings in January, March and November. Attendance was good at all meetings.

The Finance Subcommittee oversees the annual operating budget and grant programs. The annual LEPC budget of \$122,153.00 for fiscal year 2019-2020 was approved by the Corpus Christi City Council. These funds were provided through donations from entities within Corpus Christi and Nueces County. A request to Corpus Christi City Council was approved to transfer \$33,926.39 from LEPC reserve fund balance to the 2019-2020 operating budget, creating an amended budget of \$156,079.39. These funds were received and facilitated: the purchase of a new podium for the Corpus Christi Fire Department training room, reprinting of the LEPC activity book, the purchase of local media spots, the purchase of items for 600 shelter-in-place kits and painting/wrapping the LEPC van.

A revised LEPC contribution schedule, created by an Ad Hoc Finance Committee in 2019 and implemented the same year, was again followed in 2020. Donations are now being requested from Tier II reporting facilities, as well as facilities not subject to Tier II reporting requirements but subject to federal contingency planning requirements. Since the new contribution schedule was adopted, donations to the LEPC have been maintained and/or increased.



Thanks to the LEPC's industrial partner, Plains All American Pipeline, the Corpus Christi Fire Department received a donation of \$4,063.31 through the Plains First Responder Grant Program. The funds will be used to purchase equipment for CCFD's Hazmat Team.

The Subcommittee continues to work in cooperation with local business and industry to improve awareness regarding chemical emergencies and safety, as follows:

- Many events and meetings were cancelled in 2020, limiting the opportunity for outreach. The LEPC did present to the Corpus Christi Community Advisory Council (CCCAC) in February, as well as provided an audio presentation and informational materials to the CCCAC for goody bags in October. The LEPC was one of the sponsors of the virtual Coastal Bend Hurricane Conference in July.
- The Subcommittee purchased television commercial airtime for the "Chemicals are Everywhere" campaign, which focused on the use, storage and disposal of chemicals in the home, kitchen and garage. The commercials aired 1,132 times during the months of June and August 2020.

Participation in ReverseAlert, an emergency notification system, went from 20,017 opt-in participants in 2019 to 25,694 opt-in participants in 2020, an increase of 28.4%. During the year, 57 industry alerts were sent out through the ReverseAlert system. The LEPC supported the City of Corpus Christi's and Nueces County's rip current initiative, which added potential rip current danger information to ReverseAlert messaging. The LEPC provided more than 21,500 ReverseAlert cards for distribution to the Corpus Christi Convention and Visitors Bureau, Nueces County, hotels and tourist destinations.

#### **OUICK GUIDE: PIPELINE LEAKS**

#### **WARNING SIGNS OF A PIPELINE LEAK**



If you suspect a pipeline leak, call 911 immediately

#### **Detecting Leaks**

Although pipeline leaks don't happen often, it's important to recognize the signs of a leak and know what to do if a leak is suspected. The more you know, the safer you are!

- **Sight:** Seeing a white cloud, mist, fog, blowing dust, bubbles on standing water, dry spots in moist areas, or dead vegetation surrounded by live, green plants may indicate a
- Sound: Hearing an unusual sound like roaring, hissing, or whistling is an indication of a natural gas leak.
- Smell: In its raw state, natural gas is coloriess and odoriess. Utility companies use a substance called Mercaptan to create a "rotten egg" smell. Take action even if you only detect a slight odor of natural gas.

#### What TO DO if You Suspect or Detect a Leak

- Leave the area immediately in an upwind direction. Do not try to find or stop the leak. Warn bystanders away from the
- Call from a safe location away from the leak. Immediat call 911 or the owner of the pipeline. Do not go back to where you smelled, saw or heard a possible leak.

#### What NOT TO DO if You Suspect or Detect a Leak:

- Do not use an open flame or ignition source. Do not smoke, start motors, ring doorbells, light matches, turn lights on or off or operate any vehicle or equipment that could cause a spark.
- Do not touch or come in direct contact with gases or liquide.
- · Do not drive into a vapor cloud or leak.
- Do not attempt to close any valves yourself or extinguish a fire.

## EMERGENCY SAFETY KIT





In 2020, the LEPC received funding for approximately 600 shelter-in-place kits. The LEPC delivered 105 shelter-in-place kits to London ISD in November and 47 kits to Joseph T.
 Dawson Elementary in December. Each kit includes duct tape, masking tape, a bottle of water, towel, first aid kit, combination radio/flashlight and emergency contact information in a large poly bag. All-hazard radios were provided to schools and public facilities for early warning of chemical incidents or hazardous weather conditions.

Other LEPC activities completed in 2020 include:

- The purchase of a new podium for the Corpus Christi Fire Department training room.
- Attending numerous Zoom/WebEx/Go To Meetings online, including with the Damage Prevention Council.
- · Completed CPR training.

- Collaborated with the City of Corpus Christi's Storm Water Department and Coastal Bend Bays & Estuaries on the creation of flyers outlining the Do's and Don'ts of Pesticide and Fertilizer Use.
- Collaborated with Coastal Bend Bays & Estuaries on the completion of a grant that was started in 2019, to distribute and collect soil samples from across Corpus Christi. A total of 244 samples were collected.

# EMERGENCY RESPONSE AND COMMUNICATIONS SUBCOMMITTEE

The Emergency Response and Communications Subcommittee (ERC) membership is a combination of first responders, industry representatives and regulatory agencies which promote preparedness for a wide variety of potential hazards.

- Due to COVID-19 restrictions, site visits at major facilities were extremely limited for first responders. Corpus Christi Fire Department did complete a tour of EPIC.
- Drills and training exercises were also curtailed because of COVID-19 precautions. The LEPC did observe a fire drill at Flint Hills Resources in January.
- Valero hosted a meeting of the ERC Subcommittee in January, and presented information on the history of the Valero organization.

# EMERGENCY RESPONSE AND COMMUNICATIONS SUBCOMMITTEE

 The LEPC and members of the Corpus Christi Fire Department attended the International Hazardous Materials Conference virtually. The LEPC continues to work with the International Fire Chiefs Association (IFCA) Technical Advisory Group. A scheduled all-hazards conference with IFCA in Corpus Christi was cancelled, with plans to reschedule in 2021.



 A three day rail car safety training and drill with Union Pacific Railroad, O.N. Stevens Water Treatment Plant, Corpus Christi Fire Department, Corpus Christi Police Department, City of Corpus Christi Emergency Operations Center and area fire departments and agencies scheduled for February 2020 - was cancelled because of COVID-19 concerns. Planning for a rescheduled event began in late 2020, with the new dates of February 9-12, 2021.

# PIPELINE DAMAGE PREVENTION SUBCOMMITTEE

Several area pipeline companies and organizations are active in the Pipeline Damage Prevention Subcommittee. This Subcommittee oversees the Corpus Christi Pipeline Ordinance, provides educational outreach and safety training.

 A safe digging utility insert was mailed out in April to more than 98,000 Corpus Christi and Nueces County homes, reminding residents to practice safe digging by calling 811 before starting any projects.



- During 2020, the LEPC Pipeline Damage Prevention Subcommittee was recognized with virtual proclamations from the Corpus Christi City Council and Mayor, as well as the Nueces County Judge and Commissioner's Court during Safe Digging Month for efforts to increase digging safety and awareness in the City of Corpus Christi and Nueces County.
- Radio and television scripts for advertising pipeline safety were developed in 2020, with production of the commercials to begin in 2021.
- Discussions were held with Subcommittee members as well as the Damage Prevention
  Council and the Corpus Christi Gas Department about the growing number of line strikes in the
  area. Ideas for meeting with companies and individuals at work sites tail-gate style were
  discussed but were put on hold because of COVID-19.


